Membership Type	Description	Annual Dues
Full Skating Member – Junior (under age 18)	An amateur member, <u>under the age of 18</u> , who has full skating rights. Full skating rights include ice contracting, USFSA competitions and USFS testing. (Example – first club child skater)	\$105.00
Full Skating Member – Senior (age 18 or older)	An amateur member, <u>age 18 or over</u> , who has full skating rights. Full skating rights include ice contracting, USFS competitions and USFS testing. This membership also includes the right to vote in club elections and hold club offices.	\$105.00
Subsequent Full Skating Family Member – Junior	A subsequent amateur member, <u>under the age of 18</u> , of the same family of another Full Skating Member. Skater has full skating rights, including ice contracting, USFS competitions and USFS testing. Choose whether you want to receive a second copy of <i>Skating</i> magazine and select the appropriate membership. (Example – second child skater in same family)	With 2 nd Copy <i>Skating</i> Magazine \$65.00

Subsequent Full Skating Family Member – Senior	A subsequent amateur member, <u>age 18 or over</u> , of the same family of another Full Skating Member. Subsequent Parent Associate Member	A subsequent parent of a Full Skating Member – Junior. (Optional) Only one Parent Associate has the right to vote in club elections.	\$30.00
Teaching Professional Member	A person who is no longer eligible to be an amateur skater and has been approved by the board of directors to teach on club ice. This membership has no right to vote or hold office in the club, but may serve as a director.	\$80.00 or \$210.00
Active Associate Member	A member who has no skating rights but wishes to support and maintain contact with the club. This membership includes USFS membership but no club voting rights.	\$50.00
Associate Member	A member who has no skating rights but wishes to support and maintain contact with the club. This membership does <u>not</u> include USFS membership or club voting rights.	\$20.00
Honorary Member	A member who, because of past service to the club, has been approved by the board of directors as an honorary member. This membership includes membership to USFS at the club's expense, but does not include club voting rights.	\$0.00

Second Club – Parent Associate Member	A parent of a Second Club Member – Junior. (This membership is required with any Junior Skating Memberships.)	\$25.00
Second Club – Teaching Professional Member	A teaching professional member, who is a member of another club which registers the member with USFS.	\$40.00
